<b>Other Business - Use of Aliases</b>	<p>You should have all received a message from David Samuelson requesting the AB to consider the possibility of establishing a policy on the use of aliases. If you did not receive a copy, I can provide you with one.</p> <p>He says in part:</p> <p>I had been in discussion with Rootsweb about the use of aliases. They have no clear policy on aliases involving accounts they own and assigned to many in the USGenWeb Project.</p> <p>I had been reading (XXGenWeb's) feelings about the aliases, one calling for prohibiting the aliases outright, requiring actual CC name be listed on affiliated County sites.</p> <p>Clearly there is a big need for Project policy to outlaw use of aliases to hide themselves. As far as I know there were 2 reports of aliases and possibly 3rd one. Every one of them were in together.</p> <p>(YYGenWeb) had a problem with one SC using alias before that person practically disappeared with no way to locate her and had to replace her over a year ago.</p> <p>Should USGenWeb have a project-wide policy on the use of aliases? If so, what should that policy be? What exceptions should be made?
