15 October Standard Rule XII. Advisory Board selects Secretary.

1st Monthly Special Rule III. Presiding Officer initiates preparing Monthly Minutes by Secretary.

Special Rule IV. Presiding Officer posts Monthly Order of Business.

As Occuring Special Rule V. Presiding Officer posts to Board from Announcements List.

Special Rule VI. Presiding Officer uses General Consent where possible.

Special Rule VII. Presiding Officer uses Informal Consideration where possible.

Special Rule IX. Electronic Motions Minimum Wait Times.

A change to the bylaws was suggested; one which would define who a member is, i.e., County Coordinator, etc. The way the bylaw is worded it is not necessary, in my opinion, to add/change the bylaw itself but under the Rules process we can define/supplement the bylaw by an exact definition of a member through a standard or special rule. A plus to that would be that as membership evolves it is far easier to change a Rule than a Bylaw.

At one time we had a motion on the floor in an attempt to define. At that time I received some input on the issue of defining membership from Pat Asher that made perfectly clear sense to me; however, I can't find that little bugger. Then, the motion got overtaken by a higher priority event(s) so it got pushed to the back burner. It's on the front burner again. I've either lost the Pat input or I put it under a location that has a dozen locks/keys. As I recall, defining a member is not as clear as it first sounds.

Bylaw VII. F. ELECTION PROCEDURES, which says:

"All members of The USGenWeb Project, excluding Look-Up Volunteers

and Transcribers, shall be eligible to vote."

This section acknowledges "Look-Up Volunteers and Transcribers" as non-voting "members." However, the EC does not have, and to the best of my knowledge has never had a way to include look-up volunteers or transcribers on the membership rolls. The EC dataset (Oversight) only includes those members who maintain a website within the USGW hierarchy of States or Special Projects. Any change to the definition of member would have to take VII. F. into consideration, as well as Bylaw IV. A. MEMBERSHIP.

Also, after serving as Dataset Manager of the EC for several years, I have become aware of a problem with resolving chronic bouncing email addresses. We currently have 24 names on the membership roll who are designated as chronic bounces (have bounced 3 or more times). Fifteen (15) of these email addresses were first identified as bouncing almost two years ago in November 2015. Under current rules, the EC can not remove these names from the membership roll without authorization from the project coordinator or the member. If the project coordinator does not respond and the EC can't reach the member via email, what should the EC do?
